



Virginia Headwaters Council Campership Application Instructions

Camperships are available for registered youth and adults attending summer camp in the Virginia Headwaters Council of Scouts BSA. This fund assists youth and adult members with **up to 50% of the camp fees** based on need, and is not intended to cover the full fee. **Families, units, and/or the chartered partner are expected to contribute towards the fee as they are able.**

Scout parent/guardian and the unit leader should have an initial conversation together about the need for campership, and establish what the Scout family and the unit is able to contribute to the fees prior to filling out the form. The unit leader should also check in with their chartered partner to see if the chartered organization can contribute as well.

Council scholarships are made possible by ongoing contributions from other Scouts, families, and leaders. To that end extra consideration will be given to applicants and units who have helped support council fundraisers or events in the past or are committed to doing so in the future.

Please read all instructions completely and fill in all spaces. If you have more than one Scout/Scouter/parent asking for campership in your family, fill out a separate form for each member but submit them together. Requests for camperships beyond the standard 50% of the fees will be considered on a case by case basis based on information provided.

The Scholarship/Campership committee will review and approve the applications within 30 days, and notify the parent/guardian and unit leader. The Council will then issue a credit to the unit's council account that can be used towards the camp fees.
